### **Our Financial Challenge**

We have 3 big financial issues at the moment:

- 1. We are being asked to pay a bigger proportion of our costs as a church, so our contribution to the Diocese is rising rapidly.
- 2. We've had a deficit of roughly £10,000 per year for the last 3 years, funded from reserves and Gift Days
- 3. We have several urgent repairs to do on the church building and on the churchyard boundary walls.

Our recent Gift Day covered this year's deficit, but it would be much better to pay our way as a church without needing Gift Days to plug the gap. We have minimal reserves.

With just over 100 members, an extra £10 per church member per month will mean we break even each year. So......


- Ministry expenses, clergy and children's work expenses

We get no additional funds from the Church of England, or anywhere else. All our income comes from church members, or our own fundraising activities.




The reason St. James' church exists is to make Jesus known, and to share the love of God with our community.

We do that through worship, prayer, work with young and old, in schools, and care homes, in homes, workplaces, community venues and church buildings. To do all that, we also have to pay the bills.

What do we spend the money on?

Parish Share (our contribution to clergy & diocesan costs)	76,290
Wages (admin & cleaning)	8,580
Church Building	11,400
Ministry expenses	1,800
Mission and Charity Giving	2,600
Other running costs	5,180
Total Expenditure	105,850

The salaries for our Youth Worker and Family and Childrens Worker are funded from Gift Days, and some regular donations. Along with St Peters, we invest a further £25,000 per year in this vital work.



#### What's covered:

- 'Parish Share', Paid to the Diocese this covers clergy salary, pensions, housing, and training of new clergy, plus a range of Diocesan support services (training, legal, finance, safeguarding, mission etc.)
- **Wages** covers wages for our Parish Administrator and Cleaner, plus wages linked to weddings (verger, bellringers)
